Item #1 Building Permit Application Update

Mr. Smith asks if the building permit has been updated to add a selection box for new construction. Mr. Johnson says that he has updated the forms and published the updated forms on the Town's website.

## Item #2 Sliding Glass Door Question

Mr. Smith asks how Staff have decided on Arbor Homes' question of whether sliding glass doors count as a window for the purposes of window requirements.

Mr. Johnson says that he consulted with Debbie Luzier, who is currently working with him on rewriting the zoning ordinance, and they agreed that doors cannot count as windows no matter how much of their surface area is glass. This is consistent with contemporary code-writing practices and prevents the use of sliding glass doors and other high-glazing doors (like French doors) as loopholes for window requirements.

Mr. Smith asks if there is any need to update the ordinance to reflect this determination, and Mr. Johnson says that they will include this clarification in the ordinance rewrite.

Mr. Johnson provides further updates on the rewrite, sharing that Mrs. Luzier has completed a draft of Chapter 1, and is currently moving right along with an eye towards the end of the year deadline for a complete draft.
